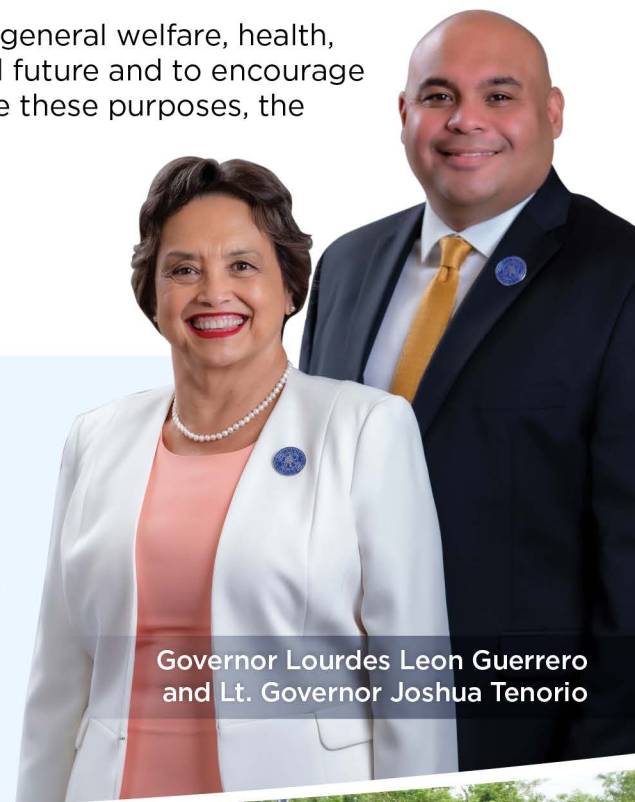
OUR COMMITMENT | GOVERNOR & LIEUTENANT GOVERNOR

OUR PROGRESS | HIGHLIGHTS

Guam State Clearinghouse

Successfully secured \$2,302,455.00 in grants for the following programs:

- \$498,272.00 Technical Assistance Program (TAP) Grant Guam Community College (GCC) First-Year Free Tuition Assistance Program for the Hospitality Industry
- \$498,225.00 Technical Assistance Program (TAP) Grant Award Amount: Guam Contractors Association (GCA) Trades Academy Tuition Assistance Program
- \$87,000.00 Technical Assistance Program (TAP) Grant Guam Grants Management System (Extended 1 Year)
- \$498,999.00 Technical Assistance Program (TAP) Grant Public Broadcasting Systems (PBS) Guam Equipment Upgrade
- \$719,959.60 Technical Assistance Program (TAP) Grant Office of the Governor Digital Archiving Project
- Guam Public Library System Archive Center Assistance Project

Bureau of Women's Affairs

- Successfully launched Project Sottera, helping girls and young women stay in school by providing free menstrual products to nurses' offices in Guam's public middle and high schools.
- Also successfully acquired \$36,000 worth of menstrual cups donated to Guam and coordinated distribution to the women's shelter and various non-government organizations
- Guam's Office of Violence Against Women successfully secured nearly \$900,000 in grants to help improve criminal justice responses to domestic violence and sexual assault.
- Also Over \$700,000 has been awarded to Guam's Community Outreach - Federal Programs that effectively helps to address domestic violence and sexual assault in our community.

Island Beautification Task Force

(Under the direction of the Office of the Lieutenant Governor)

- **Rise Up! Guam Cleanup (roadways) June 1, 2019.** This cleanup effort focused on having the 1st ever island wide participation of Government of Guam Employees partnering together, to beautify the island while giving back to the community in preparation for Liberation 2019 festivities.
- **Island Wide Bus Stop Cleanup August 10, 2019.** The Island Beautification Task Force in coordinated effort with Guam Department of Education prepared bus stops for the opening of School Year 2019-2020. Bus stops were selected by the Mayors Council of Guam.
- **Give Us A Moment #GUAM Island Pride Beautification Event June 27, 2020 & August 1, 2020.** The Island Beautification Task Force joined forces with the Guam Visitors Bureau to host the island wide cleanup in preparation for the reopening of Guam to tourists. Government of Guam agencies and departments were assigned to major roadways and parks. An estimated 11 tons of trash were collected inclusive of tires, whitegoods, and metallic waste and removal of abandoned vehicles.

War Claims

- The first group of 1,143 war claimants of Guam's World War II, have been certified and received their compensation of \$12,108,000.00
- Additionally, 21 War Claimants have been approved and are awaiting \$228,000 in compensation. A total of \$12,408,000 will be paid in compensation to survivors and victims.



Medical Referral Assistance Office

- The Medical Referral Assistance Office successfully assisted 1,805 individuals in the community seeking assistance for medical services needed off island in three locations: Honolulu, Hawaii, Los Angeles, California, and Manila, Philippines. The office provides guidance in navigating the cities in addition to assistance with lodging and transportation.
- An average of 130 individuals monthly are referred to the Medical Referral Assistance Office seeking support.

OUR FINANCES | FISCAL YEAR 2019

“The Government of Guam has decreased its general fund deficit by more than 50 percent,” Governor Lou Leon Guerrero said, citing an independent audit by Deloitte & Touche recently released by the Office of Public Accountability. Under our Administration we have paid obligations from past administrations.

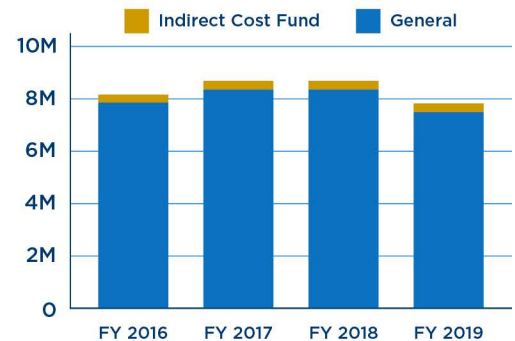
Highlights from the Office of Public Accountability *Overall, GovGuam’s surplus was attributed to revenues for governmental activities of \$1.4B exceeding expense activities by \$48.7M. General revenues derived primarily from taxes, increased by \$21M compared to the prior year. The three highest tax increases were from gross receipts tax (\$45.3M), tobacco tax (\$6.9M), and real property taxes (\$3.4M). Section 30 federal income taxes, however, decreased by \$749K.

We will strive to be worthy stewards of the public’s trust. Fiscal stability and discipline are the pursuit of our Administration

- We will commit to set aside two (2) percent of General Fund revenues placing us on a responsible path towards eliminating our deficit and establishing a Rainy-Day Fund.
- The building of cash reserves will help improve our government’s credit and bond ratings for critical capital and infrastructure improvement.

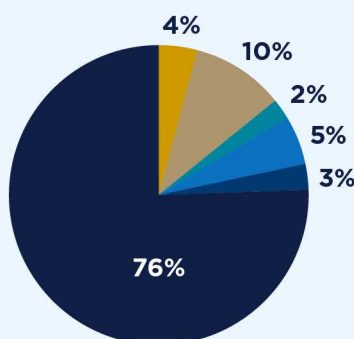

OUR VISION FORWARD

G3 Action Framework aims to develop sustainable solutions for Guam

- Executive Order 2019-23 G3 Action Framework is facilitated by the University of Guam Center for Island Sustainability
- Green Growth plan is a 10-year strategy to develop tangible solutions to sustainability challenges faced by the island and contribute to Guam's green economy. Guam is ready to take our place at the global forefront of island sustainability.
- To preserve Guam for tomorrow, we must clean up the environment and turn trash into an economic opportunity for Guam. G3 will give our people an ownership role in the new green economy and the transition toward a cleaner, more sustainable Guam.
- Five categories of action - 1) Healthy and Prosperous Communities; 2) Educated, Capable, and Compassionate Island; 3) Sustainable Homes, Utilities, and Transportation; 4) Thriving Natural Resources; and 5) Sustainable Alliances. Cross-cutting elements are incorporated into all categories—climate action, resilience, public engagement, policy, and the core CHamoru values of respect, cooperation, and treating others with kindness, generosity, and dignity.

Office of Technology Government Automation

- To provide professional and technical services for the Government's infrastructure projects and technical support to the community, at the same time developing an organized approach to information resource management for the Government of Guam (provide information/technology/communications services to all administrators of the various agencies/programs in the design and management of information systems).
- Develop a mechanism for identifying those instances where information systems should be linked, and information shared
- Monitor trends and advances in information technology and technical infrastructure and create new technologies to be used in government, convene conferences, and develop incentive packages to encourage the utilization of technology
- Direct the compilation and maintenance of an inventory of information technology and technical infrastructure, to include personnel, facilities, equipment, goods and contracts for services, wireless tower facilities, geographic information systems, and any technical infrastructure or technology that is used for law enforcement, homeland security, or emergency services.

Time to build a New Hospital Facility

- Identify \$20 million to \$30 million for immediate work on the aging Guam Memorial Hospital while working with members of the Guam Legislature to come up with a comprehensive financial plan to get the hospital to where it needs to be while we build a new hospital.
- Identifying what grants and funding are possible through Washington along with maintaining talks with the military to discuss the return of some excess federal land in Guam as the site of the new hospital.

Continued Pandemic response and assistance

- Comprehensive restrictions are necessary. The implementation of a four-step "Pandemic Condition of Readiness" (PCOR) is a strategic, methodical approach to aid in the recovery from the pandemic and while working to reopen the island.
- Of the total Coronavirus Relief Funds, up to \$20 million has been set aside for direct assistance to small businesses experiencing business interruption due to the COVID-19 pandemic. The program is administered by the Guam Economic Development Authority
- An allowance of grants and low interest loans with deferred periods through the Guam Economic Development Authority (GEDA) is setting the Leon Guerrero Administration apart nationwide for helping small businesses.

We are working daily to provide the resources we need to keep us safe, care for those who care for us, pay down our debt, and continue to eliminate the deficit we inherited. These are not for the glory of a single day, but for the knowledge that we will leave Guam a better place for our children and grandchildren.



A simple mission drives us forward: to be good stewards of the trust bestowed on us by the People of Guam. To that end, our vision must overcome our daily challenges and always focus on our gaze toward the future. services.
