On March 15, 2020 the first cases of COVID-19 struck the Island, followed by the executive orders to cease operations of non-essential Government Agencies to curb the spread of the virus. I liheslatura was forced to adjust to ensure that legislative operations would persist through pandemic restrictions. This would be made possible by shifting legislative events on to the virtual conferencing platform; Zoom. Through Zoom, public hearings, resolution presentations, and other legislative proceedings were made possible despite the Guam Congress Building being closed to the public.

While Legislative Session was still conducted in-person, I liheslatura established contactless document distribution on cloud-based software solutions. This would circumvent the need for physical document distribution, reducing the risk of exposure to COVID-19, but also drastically decreased our environmental impact in regards to paper waste.

This technological shift has created a more open and accessible legislative branch to the island's residents and to viewers from across the world. Beset by pandemic and lockdown, the legislative branch has adapted to meet an uncertain future to fulfill its duty to the island of Guam.



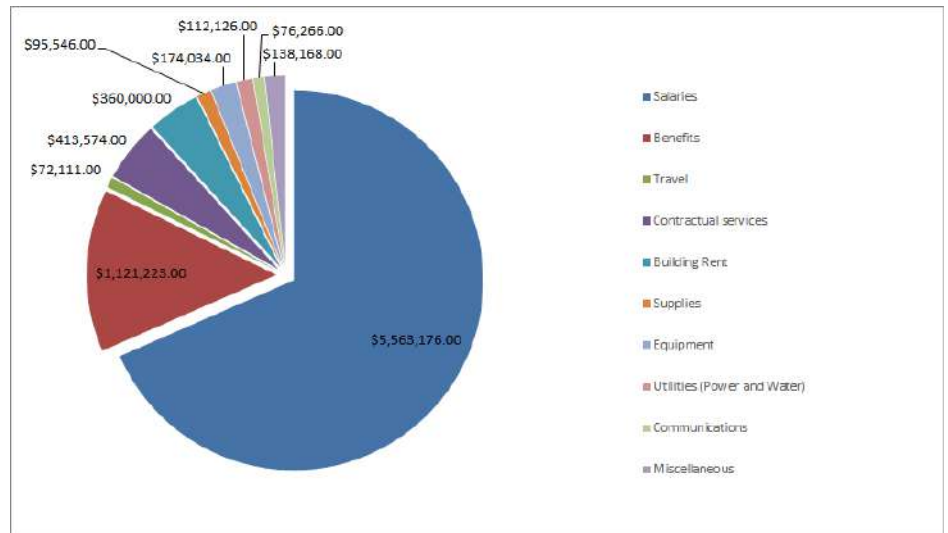

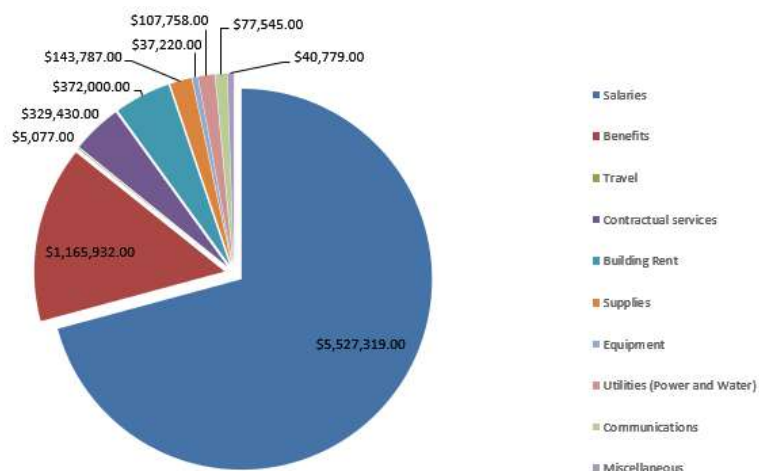
