### ABOUT US

The Guam PEALS Board was established in 1960 to oversee the licensing of Engineers, Architects and Land Surveyors. To carry out our mission, the PEALS Board coordinate and monitor activities relating to the licensing of Engineers, Architects, Landscape Architects and Land Surveyors. Since then, the PEALS Board has seen an increase in registration for individuals and firms. In FY2017 there were about 115 firms and 815 registered Individuals.

### MISSION STATEMENT

Our mission is to safeguard the life, safety and welfare of the general public by ensuring that the professionals adhere to established laws and promote their professions within the guidelines of ethical practice.

The Guam PEALS Board is made up of Seven (7) members. All were appointed by the Governor of Guam to serve for a total of Four (4) years except for the Director of Public Works. Of the seven members, two (2) shall be registered Architects, two(2) shall registered Engineers, one (1) shall be a registered Land Surveyor and one (1) Public Member.

### Administrative and Support

We provide administrative support to our registrants and firms based on the law and rules & regulations governing the professional practice of engineers, architects, landscape architects, land surveyors and construction management.

### Clear Building Permit

We clear Building Permits by assuring that the individual or firm designing the construction documents are licensed and in the discipline to provide the type of professional services.

### Examination

We approved qualified individuals to sit for the National exams and we administer the Professional Engineering Exam twice in a calendar year.

### Enforcement

We issue citations and penalized individuals and firms engaged in unlawful/unlicensed practice.

We establish standards for those licensed to practice.

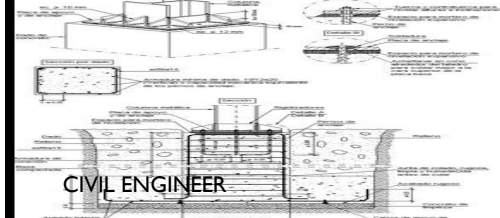
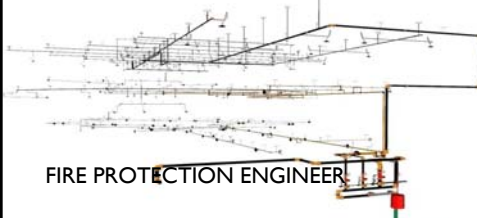
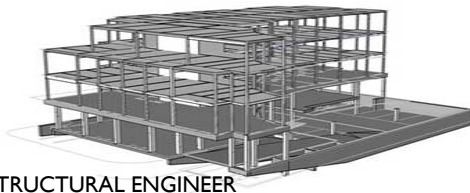

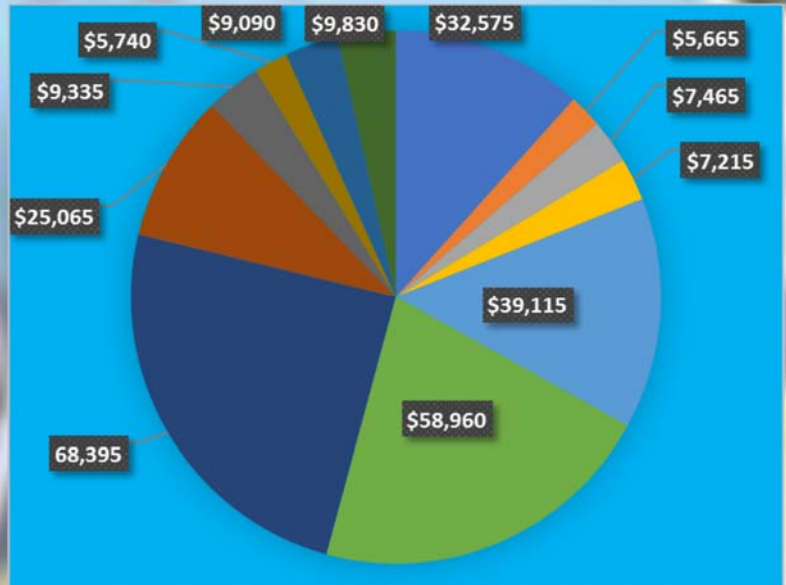


## OUR FINANCE
