
**Filing Deadline for Hearing Materials:** January 10, 2022 at 5:00 P.M.  
Parties shall file and serve on the other parties, no later than this date and time, their respective Witness Lists, Exhibit Lists with four copies of all exhibits, Admissions of Fact and List of Issues which require evidence or arguments to be presented at the hearing. The Appellant’s Exhibits shall be marked with corresponding and sequential numbers. The Purchasing Agency’s Exhibits shall be marked with corresponding and sequential capital letters of the alphabet. The Parties may file stipulated joint witness, exhibit, and issues lists, and admissions of fact in lieu of filing such documents separately. The term “Exhibit List” as used in this paragraph refers to exhibits that any party will present to a witness for testimonial purposes during the hearing in this matter.
