

So if your clearance or approval falls under that permit or license, then GFD should have the count of individuals listed, e.g. GFD requires 14 users for Building Permits of which 14 will also require plan review. I have updated the table to be in line with the format requested. Please review and let me know if the counts are different for different applications.
