WHEREAS this matter was before the Public Auditor on December 15, 2023 for hearing on GGRF's Motion to Dismiss;

WHEREAS the Motion Hearing was continued to December 21, 2023 at 9:00 a.m. to allow the Parties to meet and confer and discuss this matter;

WHEREAS Counsel for the Parties have discussed this matter and more time is needed to bring this matter and certain issues before the Parties, in particular the GGRF Board of Trustees which anticipates its next meeting on January 19, 2024,

WHEREAS the Parties therefore require more time, before moving forward with GGRF's Motion to Dismiss and the Hearing on the merits of this matter;
