Dear Mr. Mann, Mr. Day, Mr. Cook, Mr. Kim, Mr. Carrara, and Ms. Kraus:

On September 26, 2011 the Public Auditor issued its decision in Appeal No.OPA-PA-11-011 and ordered that the April 7, 2011 Letter from GCC counsel Sarah Strock which rejected the remaining bids to be vacated because the April 7, 2011 rejection was not issued under the authority of GCC's Procurement & Inventory Administrator and because it was not a written determination by the head of the purchasing agency.

This letter is a formal notice from myself and GCC's Procurement & Inventory Administrator Joleen Evangelista that all bids for IFB GCC-FB-015 have been rejected because it is in the best interest of the territory.

Notice of rejection of bids Page 2 of 2

GCC has rejected the remaining bids in the IFB pursuant to 2 G.A.R. Div. 4 § 3115 (h)(A)(iv) because prices of the remaining bids exceed available funds, and it would not be appropriate to adjust quantities to come within available funds.

Accordingly, all bidders are hereby notified that all remaining bids in IFB GCC-FB-015 are rejected because rejecting these bids is in the best interest of the territory. Please feel free to contact me if you have any questions.
