PROCUREMENT APPEALS

IN THE APPEAL OF DARREN W. GUTIERREZ, dba **G-CREW MAINTENANCE**

APPEAL NO: OPA-PA-11-014

ORDER OF DISMISSAL

Appellant

THIS MATTER came before the Public Auditor pursuant to an appeal filed on July 14. 2011, by DARREN W. GUITIERREZ, sole proprietor doing business as G-CREW MAINTENANCE, (Hereafter "G-CREW") regarding the Guam Housing and Urban Renewal Authority's (Hereafter "GHURA") decision on G-CREW's June 23, 2011 Protest concerning GHURA IFB No. GHURA / COCC / PH 011-07 for Janitorial Services. After reviewing the Mutual Agreement Statement filed August 22, 2011 with the Office of Public Accountability (Hereafter "OPA"), the Public Auditor hereby ORDERS that the appeal is now moot due to the Purchasing Agency, GHURA, granting the relief the Appellant, G-CREW, was seeking in this appeal, namely re-bidding of the janitorial services solicitation. Based on the Mutual Agreement Statement dated August 18, 2011 (copy attached for reference) that was mutually entered into, agreed upon, and signed by GHURA Executive Director MARCEL G. CAMACHO, and DARREN GUTIERREZ, sole proprietor and owner of G-CREW MAINTENANCE, the Public Auditor ORDERS the appeal be dismissed with prejudice.


