1-A GuamWEBZ,	Appellant.	PURCHASING AGENCY'S RESPONSE TO HEARING OFFICER'S REQUEST FOR ADDITIONAL INFORMATION AND EXHIBIT SUBMITTED UNDER SEAL

Purchasing Agency Guam Community College ("GCC") submits its Response to the Hearing Officer's Request for Additional Information ("Request") that directed GCC to provide the residential addresses and citizenship of "persons identified in WSI's bid as persons who would perform the IFB's scope of work" and in the March 11, 2016 email "wherein WSI disclosed a list of its employees it would assign to the project." (Request (Aug. 11, 2016) at ¶¶ 1-2.)

GCC contacted WSI and obtained the information requested.<sup>1</sup> The Guam villages of residence for the persons who will perform the scope of work in the IFB and their citizenship are provided below. To protect the privacy of these persons, WSI asked that these persons' residential street addresses be kept confidential. Thus, GCC submits these persons' entire

residential addresses under seal. (*See* Ex. A.) GCC respectfully requests the Hearing Officer to order that Exhibit A remain under seal and that the parties, their counsel and/or the Office of Public Accountability shall not disclose the confidential information contained therein. A proposed order to this effect is filed contemporaneous with the instant Response.

WSI informed that Heather Angus-Lee will not be working on the website because her services were offered only in regard to WSI's proposed "Optional Site Upgrades" (*see* Purch'g Agency's Subm'n Under Seal (Apr. 22, 2016), Ex. A (WSI's entire bid packet) at GCC-SEALED-027 - 033) — the pricing for which was not included in WSI's proposal — and GCC did not opt for these site upgrades. Therefore, WSI did not provide GCC with information regarding Ms. Angus-Lee's citizenship and address.

The citizenship and residential villages of the persons who will perform the IFB's scope of work for WSI are as follows.
