- d) The December 28, 2016 Letter from Glenn Leon Guerrero to Byung Ho Kim regarding the "Claim due to Termination and Delays of Project;"
- e) The January 24, 2017 Letter from Glenn Leon Guerrero to Byung Ho Kim regarding the "Claim due to Termination and Delay of Project;"
- f) The October 17, 2017 Letter from Joyce C.H. Tang to Glenn Leon Guerrero regarding the "Korindo Corporation Bile & Piqua Bridge Reconstruction Project, Project NO. GU-NYH-NBIS (007);"
- Page 2, Appellant's Request filed on February 9, 2018.
- 2. The Purchasing Agency did not oppose the Appellant's request to supplement the procurement record. See Purchasing Agency's Response to Appellant's Request filed on February 16, 2018.
