6. The deadline to obligate the FY 2012 grant funds identified for the purchase of the mini-buses is currently set at September 30, 2014. If GDOE does not obligate or re-program the funds by that date, the funds will revert to OSEP and no longer be available to GDOE.

7. If it appears obligation of the funds will not occur by the September 30th deadline, GDOE may re-program the funds for use in other grant-approved activities. However, re-programming may not occur without OSEP approval, and must occur prior to the deadline for obligation. I have been informed by the Federal Programs Division of GDOE that obtaining approval to re-program the funds may take several weeks. An internal deadline of June 30, 2014 has therefore been set for the application for re-programming of the FY 2012 OSEP funds.
