OUR HISTORY

On August 14, 1905, Guam's first true local policing effort was established under the control of the United States Navy. The first policemen were natives of Guam. These brave and heroic men were members of the Insular Patrol Force as part of the Guam Insular Guard. The U.S. Navy later augmented the police force with members of the U.S. Marine Corps stationed on Guam.

In 1952, the Department of Public Safety was established as a carryover from the U.S. Government-controlled Guam Insular Guard. The 1950 Organic Act of Guam paved the way for Guam's self-government and the formulation of the Government of Guam. The Department of Public Safety was entrusted with the authority to enforce the laws of the territory and federal statutes applicable to Guam. Furthermore, the Department was responsible for the administration and operation of the former Guam Penitentiary and Fire Division.

Effective March 13, 1985, pursuant to Public Law 17-78, the Department of Public Safety was separated into two departments - the Guam Police Department and the Guam Fire Department.

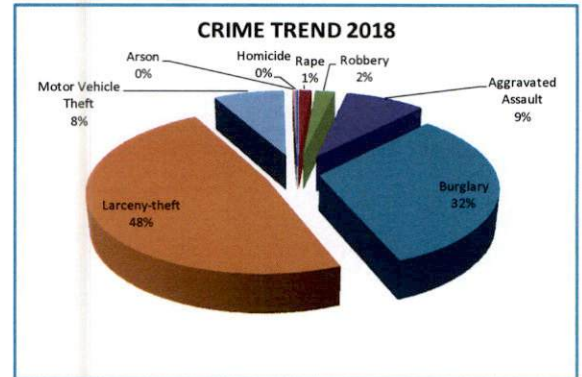

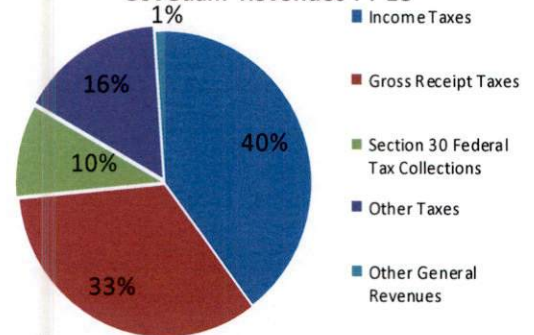

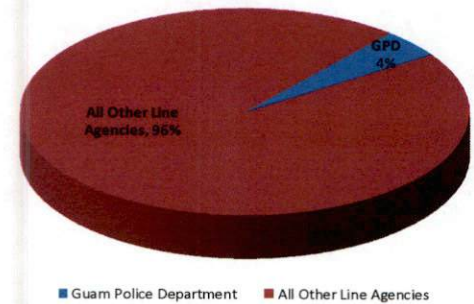
GovGuam Revenues FY'18

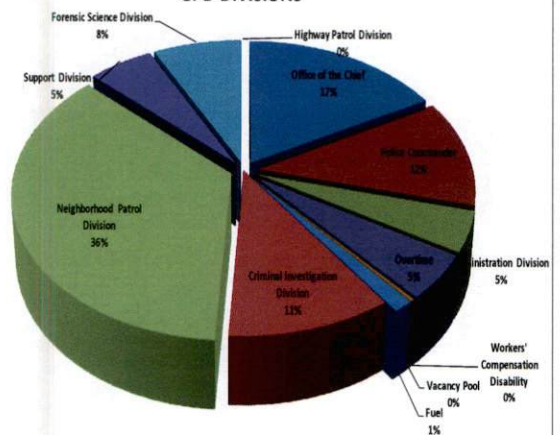
GPD Revenue Impact

CHALLENGES AND FUTURE OUTLOOK

BUDGET SHORTFALL

The Guam Police Department consistently submits sound proposed budgets to provide essential services, and implement mission-essential programs. However, appropriations continue to fall short. GPD expends ninety-three percent (93%) of its fiscal year budget on personnel cost, which includes salaries, benefits, and overtime.

Throughout FY 2018, overtime expenditures were carefully managed through changes in assignment, augmentation, and scheduling. Although GPD maintains its efficiency of operations, ongoing budget shortfalls will negatively impact its ability to meet goals, objectives, and provide effective police services to the community.

HIGHLIGHTS

COMMUNITY PARTNERSHIPS

Initiatives developed and implemented at the start of FY 2017 launched the Guam Police Department's shift from traditional policing, to the evolution of police services through community partnerships.

The Neighborhood Watch Program, which has grown to more than thirty-eight (38) groups in sixteen (16) villages, has brought longstanding and new neighbors together, and incorporates interaction between generations and cultures. The Business Watch Program has more businesses engaging in safety and security discussions with GPD. Officers in the field have established a robust safety network among a growing array of businesses, from "Mom & Pop" village stores to boutique shops and hotels in the tourist district. GPD's message of partnering with the community was carried throughout a broad range of age groups through the Coffee With A Cop, Cookies With A Cop, Junior Police Cadet, and D.A.R.E. programs.

SPECIAL INVESTIGATION SECTION

The Special Investigation Section's enforcement and interdiction of illicit drugs and activities resulted in over one hundred (100) drug arrests and served search warrants, and the seizure of more than one thousand (1,000) grams of illicit drugs.

SIS and SWAT members seized more than thirty-five (35) pounds of cocaine valued at over one million dollars (\$1,000,000) - the largest seizure of Cocaine to date, and the largest seizure of illicit drugs in the history of the Guam Police Department. The team served several search warrants and arrested ten (10) individuals related to the seizure.

The drug of choice on Guam however, remains to be crystal methamphetamine. SIS remains diligent and our federal counterparts have taken a more intimate role in operations, strengthening our efforts and working relationship.

FUTURE OUTLOOK

CAPITAL IMPROVEMENT PROJECTS

- The newly constructed Central Precinct Command in Sinajana is expected to open in the latter part of 2019.
- Renovation of the Environmental Control System at the GPD Forensic Science Laboratory, is ongoing.
- Plan to construct a new Evidence Control Section (ECS) building in Yigo is ongoing.

IMPROVEMENTS

In its continuing effort to provide quality police service, GPD plans to:

- Recruit uniform and civilian personnel.
- Purchase police vehicles.
- Upgrade computer systems.
- Update and/or create policies/procedures.
- Collaborate with GBHWC to address mental health-related calls for service.


