The parties shall file and serve on the other parties, their Hearing Briefs summarizing their arguments concerning contested issues no later than this date and time. October 22 and 23, 2012 at 9:00 A.M. **Hearing Date:** The Hearing will proceed in the following order: (1) Opening Statements of the Parties; (2) Appellant's Case in Chief; (3) The Purchasing Agency's Case in Chief; (4) Closing Statements of the Parties. **SO ORDERED** this 9<sup>th</sup> day of August, 2012.
