The Office of the Attorney General, on behalf of the General Services Agency (“GSA”), submits this Motion to Strike Appellant’s Comments to the Agency Report, because JJ Global filed the comments ten days late.

According to 2 GAR Sect. 12104 (c)(4), JJ Global had ten calendar days after the GSA filed the agency report to file its comments to the agency report. GSA filed the agency report on November 23, 2021. Ten calendar days after this date was November 30, 2021.

JJ Global filed its comments to the agency report on December 9, 2021—nine days after the deadline for filing had passed.

2 GAR Sect. 12104 (c)(5) states that failure to heed the time limits set in this provision may result in the Office of Public Accountability deciding the Appeal without considering comments. GSA moves to strike JJ Global's comments because JJ Global failed to file before the deadline that the OPA set in its rules.
