7. I have been involved as an evaluation committee member in other Guam

procurement matters.

8. As a specialist on Guam Procurement law, I am familiar with the Standard

Operating Procedures, industry standards, and the procurement practices of the

various Guam agencies (collectively hereinafter "Guam procurement laws and

agency standards").

9. I am familiar with the facts of this procurement appeal.

10. Based upon my information, belief, and personal knowledge of the Guam

procurement laws and agency standards, Guam agencies allow individual

evaluation committee members to independently evaluate proposals, but they do so

in a group setting and supervised by procurement officials in order to ensure

compliance with the law.

11. Based upon my information, belief, and personal knowledge of the Guam

procurement laws and agency standards, until this case, no Guam agency has ever

allowed individual evaluation committee members to take home proposals and

independently evaluate them. This is because the purpose of the procurement law

is fairness and impartiality. Evaluators are not supposed to lie, cheat, or divulge

certain information. It is not possible to ensure compliance with the procurement

laws when evaluators are allowed to take home proposals and evaluate them

unsupervised.

12. Based upon my information, belief, and personal knowledge of the Guam

procurement laws and agency standards, Guam agencies select individual

evaluators based on their experience that is relevant to the specific type of bid or

proposal. For example, in construction contracts, Guam agencies normally select

evaluators that are engineers, architects, contract management supervisors or

directors and are qualified to evaluate a construction contract.

13. Based upon my information, belief, and personal knowledge of the Guam

procurement laws and agency standards, Guam agencies do not select evaluators

who lack the education, experience and expertise in the relevant areas to evaluate

bids or proposals.
