- 2 a. Formulation and simplification of issues;
- 3 b. Possibility of obtaining admissions of fact and of documents that will avoid
- 4 unnecessary proof, stipulations regarding the authenticity of documents, and advance rulings
- 5 from the Hearing Officer on the admissibility of evidence;
- 6 c. The avoidance of unnecessary proof and cumulative evidence;
- 7 d. The identification of witnesses and documents, the need and schedule for
- 8 filing and exchanging pretrial briefs;
- 9 e. The disposition of pending motions;
- 10 f. The need for adopting special procedures for managing potentially difficult
- 11 or protracted actions, complex issues, multiple parties, or unusual problems;
- 12 g. Establishing a reasonable limit on time allowed for presenting evidence; and
- 13 h. Such other matters as may facilitate the just, speedy, and inexpensive
- 14 disposition of the action.
