1. The Pre-Hearing Conference will focus on expediting the disposition of the appeal and may include:
 - a. Formulation and simplification of issues;

1 b. Possibility of obtaining admissions of fact and of documents that will avoid
2 unnecessary proof, stipulations regarding the authenticity of documents, and advance rulings
3 from the Hearing Officer on the admissibility of evidence;

4 c. The avoidance of unnecessary proof and cumulative evidence;

5 d. The identification of witnesses and documents, the need and schedule for
6 filing and exchanging pretrial briefs;

7 e. The disposition of pending motions;

8 f. The need for adopting special procedures for managing potentially difficult
9 or protracted actions, complex issues, multiple parties, or unusual problems;

10 g. Establishing a reasonable limit on time allowed for presenting evidence; and

11 h. Such other matters as may facilitate the just, speedy, and inexpensive
12 disposition of the action.
