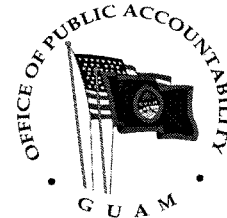
8 THESE MATTERS came before the Public Auditor on January 11, 2013 pursuant to the

- 15 3. Each party shall submit a hearing memorandum no later than February 26, 2013.
- 16 4. The Formal Hearing scheduled for January 21 through 23, 2013 had been rescheduled to

- 18 5. The aforementioned scheduling dates are contingent upon the Public Auditor's decision
19 on the motion to dismiss which will be issued on or before January 31, 2013.
