MEMORANDUM OF POINTS AND AUTHORITIES

Appellant Harbor Center Guam respectfully requests a continuance of one month pursuant to 5 G.C.A. § 9223, which states that an agency may grant continuances at any stage of the proceedings. Appellant requires testimony from material witness, Claudia Acfalle,, who is currently off island on a personal matter. Appellant's legal counsel has not been able to contact this material witness via telephone since this appeal was initiated. Her employer, General Services Agency, is unable to confirm whether she will return to Guam by the hearing date currently set for October 18, 2010. Claudia Acfalle has been uncooperative with Appellant's counsel and she sent emails to stating that she does not know when she will return to Guam, she is unable to provide a phone number, and she has not indicated where she is currently located. See attached Exhibit "A."

Claudia Acfalle is Appellant's main witness and Appellant is unable to proceed with this appeal without her testimony. Since Claudia Acfalle is being uncooperative, Appellant requests that the Office of Public Accountability grant a one month continuance for the Hearing currently set for October 18, 2010 at 9:00 AM pursuant to 5 G.C.A. § 9223, in order to allow Appellant to subpoena material witness Claudia Acfalle.

Additionally, Appellant intends to depose several other material witnesses, namely the Port Authority of Guam employees who independently evaluated the various proposals in this appeal, and Alma Javier, Chief Procurement Officer of Port Authority of Guam. In addition to Claudia Acfalle and Alma Javier, the individuals on the evaluation committee that need to be deposed and subpoenaed include: John B. Santos, Operations Manager; Ernie Candoleta, Maintenance Manager; Joaquin Pangelinan, Equipment Support Services
