
1 1. The Purchasing Agency's July 13, 2011 request that the Office of Public

4 the procurement record in this matter is hereby GRANTED. However, the Purchasing Agency
5 shall, no later than 5:00 p.m. on July 26, 2011, supplement said procurement record with all
6 documents required by 5 G.C.A. §5249 and 2 G.A.R., Div. 4, Chap. 3, §3129 from August 3,
7 2010, the date the Appellant filed its initial protest concerning GCC-IFB-10-015 (Voice Over
8 Internet Protocol (VoIP) Telephone System Project), to the date of this order.

11 2. The Appellant shall have until 5:00 p.m. on July 29, 2011 to file its Comments on the
12 Agency Report and serve a copy of the same on the Purchasing Agency.

13 3. The Purchasing Agency shall have until 5:00 p.m. on August 5, 2011 to file its
14 Rebuttal to the Appellant's Comments on the Agency Report and serve the same on the
15 Appellant.

16 4. The Parties shall acknowledge receipt of this Order and return the same to the Office
17 of Public Accountability immediately.
