- 2. The Appellant shall have until 5:00 p.m. on July 29, 2011 to file its Comments on the Agency Report and serve a copy of the same on the Purchasing Agency.
- 3. The Purchasing Agency shall have until 5:00 p.m. on August 5, 2011 to file its Rebuttal to the Appellant's Comments on the Agency Report and serve the same on the Appellant.
- 4. The Parties shall acknowledge receipt of this Order and return the same to the Office of Public Accountability immediately.
