Re: Procurement Appeal OPA-PA-12-012, Comments on GSA Agency Report

Dear Mrs. Flores-Brooks:

This letter represents comments from Appellate, Pacific Data Systems (PDS), on the GSA Agency Report and Procurement Record in the above referenced Procurement Appeal.

In point (g) of its Agency Report and the referenced Notice that GSA provided to bidders on May 18, 2012, (Exhibit A), GSA attempts to justify its failure to make a determination on pending protests due to the appeal filed by PDS on May 17, 2012, (this appeal was later designated as OPA-PA-12-011). Though the PDS appeal only dealt with the award of one part of the bid¹. GSA has chosen to use the PDS appeal as a justification for doing nothing further in the procurement, though there are 5 protests pending in the procurement². GSA' position is based on a mistaken belief that the stay of the procurement referenced in its report (5 GCA Section 5425g) justifies GSA ceasing any and all work to resolve or to make a determination in the pending protests. A clear reading of this whole section of law, particularly 5 GCA Section 5425c, should have answered any questions that GSA had related to whether it needed to take "prompt" action on this issues. Instead, GSA, by its memo of May 18, 2012, chose to take "no action" on these pending issues.

In point (i) of its Agency Report, GSA references a pending Taxpayer Lawsuit filed against Claudia Acfalle (CV0647-11). This case does not involve this GSA procurement and Claudia Acfalle has previously stipulated that she had recused herself from all matters related to this procurement (see Exhibit B).

GSA IFB-064-011 had a total of 12 parts, each which was awarded individually. The PDS Appeal only dealt with one of the award decisions by GSA; Part 10

Protests have been filed by PDS (filed 5/09/2012), MCV (filed 5/10/2012), Docomo Pacific (filed 5/10/2012), IT&E (filed 5/10/2012), and GTA (filed 5/18/2012).



The Agency Report produced by GSA reinforces the basis for this PDS Appeal to the OPA and underscores the need for the OPA to take up this issue and use her discretionary powers and to compel GSA to make a determination in the pending protests in this procurement.

PDS renews its request that the OPA deal with this matter on an expedited basis in order to restore the integrity of the procurement process and force GSA to deal with these long pending issues.

Since Appellant, PDS, believes the facts in this appeal are undisputed by the parties and that further delay will perpetuate the current untenable situation, PDS waives its right to a hearing on this Procurement Appeal and requests that the OPA decide this matter based on the fillings that have been made by the parties.
