ORDER CONSOLIDATING APPEALS and SCHEDULING ORDER

Public Auditor Doris Flores Brooks and Hearing Officer Peter C. Perez, Esq., convened a pre-hearing conference in the above named appeals on April 29, 2013, on notice duly given to all parties of record. Present for Phil-Gets (Guam) International Trading Corp. dba J&B Modern Tech (J&B) were Generoso M. Bangayan, president of the company, and Seth Forman, Esq., of Dooley Roberts & Fowler LLP, counsel for the company; present for Guam Department of Education (DOE) were Marcus Y. Pido, DOE's Supply Management Administrator, and Andrew T. Perez, Esq., counsel for DOE.

In Docket PA 13-002, J&B appeals the Determination and Notice of Suspension that DOE issued to it March 21, 2013. J&B notes that the suspension is related to DOE Invitation for Bid (IFB) 050-2011. In docket PA 13-003, J&B appeals DOE's the April 3, 2013, denial of J&B's protest relative to DOE IFB 008-2013. Upon the stipulation of the parties and pursuant to the

Public Auditor's inherent authority to deal with procurement appeals,¹ it is ordered that the two appeals be and they are consolidated and all matters pertaining to the appeals shall be heard concurrently.

A single motion, that of DOE for permission to issue purchase orders in order that it may acquire new air conditioners, pends. Counsel for the parties stated on the record that they have no intent to file any additional motions.

In accordance with 2 G.A.R., Div. 4, § 12108(a), a hearing must be held in these cases because it involves a matter of suspension or debarment.

Upon consideration of the statements of counsel made at the hearing relative to scheduling, the Public Auditor orders that the following schedule is adopted and ordered:

- a. Counsel for J&B shall file its opposition to DOE's motion no later than May 6, 2013;
- b. Counsel for DOE shall file any reply to J&B's opposition no later than May 8, 2013;
- c. No later than May 10, 2013, the parties shall file their hearing briefs, a witness list, an exhibit list, and a statement of agreed facts or of such facts that are in dispute;
- d. The hearing on the consolidated appeals shall commence at 9:00 a.m., May 14, 2013, at the Public Auditor's hearing room, Room 907, DNA Building, Hagatna, Guam.

Though it was not raised at the pre-hearing conference, the Public Auditor notes that J&B has identified in its Notice of Appeal in Docket 13-003 the names of three competing bidders, namely Johnson Control, JMI Edison and Dick Pacific. It is the opinion of the Public Auditor that the competing bidders should be notified that these appeals are pending and the Public Auditor orders that counsel for DOE serve copies of this order upon the competing bidders. DOE is instructed to do this because it is the party to this appeal that is most likely to have the correct names and addresses for such competing bidders.
