A continued Status and Motion Hearing was held on July 3, 2012 before Hearing Officer Phillip Torres. Present was Jacqueline Taitano Terlaje, Esq. on behalf of the Appellant and Benjamin M. Abram, Esq., John Weisenburger, and Benita Manglona on behalf of the Purchasing Agency. At said hearing the following was ordered:

Parties shall file and serve on the other parties, no later than this date and time, their respective Witness Lists, Exhibit Lists with four copies of all Exhibits, Admissions of Fact and List of Issues which require evidence or arguments to be presented at the hearing. The Appellant's Exhibits shall be marked with corresponding and sequential numbers. The Purchasing Agency's Exhibits shall be marked with corresponding and sequential letters of the alphabet. The Parties may file stipulated joint witness, exhibit, and issues lists, and admissions of fact in lieu of filing such documents separately. The term "Exhibit List" as used in this paragraph refers to exhibits that any party will present to a witness for testimonial purposes during the hearing in this matter.

Filing Deadline for Hearing Briefs:

Friday, August 10, 2012 at 3:00 P.M.

The parties shall file and serve on the other parties, their Hearing Briefs summarizing their arguments concerning contested issues no later than this date and time.

Hearing Date:

August 13 and 14, 2012 at 9:00 A.M.

The Hearing will proceed in the following order: (1) Opening Statements of the Parties; (2) Appellant's Case in Chief; (3) The Purchasing Agency's Case in Chief; (4) Closing Statements of the Parties.
