**XEROX CORPORATION'S MOTION  
TO ENLARGE TIME TO FILE  
COMMENTS IN RESPONSE TO  
AGENCY REPORT**

Interested Party Xerox Corporation hereby moves for additional time to file its Comments in response to the Agency Report filed by the Department of Education.

Appellant IBSS filed this Appeal on November 26, 2010. DOE submitted its Agency Report and Record on December 10, 2010. According to the Rules of Procedure for Procurement Appeals, Appellant and Interested Parties may file comments to the report within ten days of the filing of the report. 2 GAR Div. 4 § 12104(c)(4).

Xerox entered its appearance as an Interested Party on December 16, 2010. As of the filing of this Motion, Xerox has yet to receive a full copy of the Agency Report and Record. Since December 14, 2010, Xerox has been requesting that DOE provide a copy, and DOE has


been unresponsive. The Agency Report and Record is also not fully uploaded on the OPA's website. Moreover, in order to provide substantive comments to the Agency Report and Record, Xerox requires not just a copy of the Agency Report and Record but also time to prepare those comments.

Xerox therefore asks that the OPA order DOE to immediately serve a copy of the Agency Report and Record on Xerox, and to allow Xerox an extension of time until December 23, 2010, to file its comments.

Counsel for Xerox has contacted counsel for IBSS who states that he does not oppose this Motion. Counsel for Xerox also contacted counsel for DOE, who as of the time of this filing was unavailable.
