1. I am one of the attorneys representing Harbor Center Guam in the above referenced case.

3. Nicole Santos confirmed that James Brooks, the husband of the Public Auditor, Doris Brooks, is employed as a paralegal at their firm.
4. A husband is an "immediate family" member as defined by 5 G.C.A. § 5601(g).

5. Cathy Cepeda confirmed that James Brooks makes more than \$2,500.00/ year at Lujan Aguigui and Perez LLP.
6. Based upon my information, belief, and personal knowledge of the legal services industry on Guam, accounts receivables from clients are deposited into the law firm's general fund.
7. Based upon my information, belief, and personal knowledge of the legal services industry on Guam, law firm employees, such as paralegals, are paid from the law firm's general fund, regardless of whether or not they worked for a particular client.
8. Based upon my information, belief, and personal knowledge of the legal services industry on Guam, if James Brooks makes more than \$2,500.00/year and James Brooks' income is paid out of Lujan Aguigui and Perez LLP's general fund thus, James Brooks has a financial interest in this appeal.
9. Based on the Public Auditor's husband's employment at Appellee's law firm, and his likely financial interest in this appeal, the Public Auditor should recuse herself from this appeal.
