THIS MATTER came before the Public Auditor on December 19, 2012 for a continuation of the hearing for the Appellant's Appeal. The Appellant Harbour Centre Guam Co., Ltd., and Harbour Centre Port Terminal, Inc., was not present and not represented by counsel. The Purchasing Agency, Jose D. Leon Guerrero Commercial Port, Government of Guam, was not present and was not represented by counsel. Interested Party Ports America, Inc., was not present and was not represented by counsel. Interested Party APM Terminals was represented by its counsel of record, Elyze J. McDonald Iriarte, Esq. Pursuant to the December 6, 2012 Notice of Continuation of Hearing Re Appellant's Appeal, the Public Auditor hereby ORDERS the following:

- 1. The Appellant was not present at the continued hearing on its appeal despite receiving the December 6, 2012 Notice, mentioned above, which placed the Appellant on notice that if it failed to appear personally at the hearing, that its appeal would be dismissed with prejudice.
- 2. The Public Auditor finds that the Appellant has discontinued its appeal by failing to meet its burden to go forward with the appeal and pursuant to 2 G.A.R., Div. 4, Chap. 12, \$12104(c)(8), this matter is hereby DISMISSED WITH PREJUDICE.
- 3. All further proceeding scheduled in this matter are hereby VACATED, and all persons subpoenaed in this matter are hereby RELEASED from said subpoena.
- 4. This is a Final Administrative Decision. The Parties are hereby informed of their right to appeal from a Decision by the Public Auditor to the Superior Court of Guam, in accordance with Part D of Article 9, 5 G.C.A., within fourteen (14) days after receipt of a Final Administrative Decision. 5 G.C.A. §5481(a).
 - 5. A copy of this Decision shall be provided to the parties and their respective attorneys,
