15 issues lists, and admissions of fact in lieu of filing such documents  
16 separately. The term "Exhibit List" as used in this paragraph refers  
17 to exhibits that any party will present to a witness for testimonial

October 6, 2014 at 10:00 A.M.


19 The Hearing will proceed in the following order: (1) Opening
