

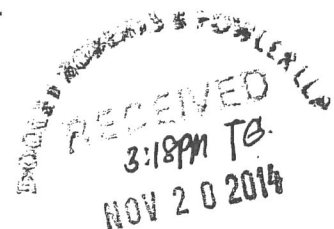

4. The Public Auditor will determine whether or not oral argument will be scheduled on the Motion.


