I, Torgun Smith, am a Certified Public Accountant and Executive Vice President for Morrico Equipment, LLC ("Morrico"), I have personal knowledge of the matters contained herein and if called to testify could and would competently do so.

1. Morrico prepared a bid in response to GPA Invitation for Bid No. GPA-064-11 ("IFB").
2. Morrico's employee, Frank Flores, spent approximately 60 hours at \$15.00 per hour reviewing the IFB package and preparing Morrico's bid response, for a total amount of \$900.00.
3. I personally spent a couple of hours on the bid preparation at a rate of \$150.00 per hour, for a total of \$300.00.
4. Morrico expended paper copying costs for approximately 100 pages at \$.15 per page, for a total of \$15.00.
5. All together, Morrico expended approximately \$1,215.00 in bid preparation costs for the IFB.
