NOTICE IS HEREBY GIVEN that a Pre-Hearing Conference shall be held before the Hearing Officer for Procurement Appeals at Suite 907, 9th Floor, DNA Building, 238 Archbishop Flores Street, Hagåtña , Guam, 96910 on Thursday, January 23, 2015 at 10:00 a.m. For the benefit of the parties and their counsel, the Hearing Officer issues the following statement regarding the scheduled Pre-Hearing conference:

1. The Pre-Hearing Conference will focus on expediting the disposition of the appeal and may include:

- a) Formulation and simplification of issues;
- b) Possibility of obtaining admissions of fact and of documents that will avoid

1 unnecessary proof, stipulations regarding the authenticity of documents, and advance rulings
2 from the Hearing Officer on the admissibility of evidence;

3 c) The avoidance of unnecessary proof and of cumulative evidence;

4 d) The identification of witnesses and documents, the need and schedule for filing
5 and exchanging pretrial briefs;

6 e) The disposition of pending motions;

7 f) The need for adopting special procedures for managing potentially difficult or
8 protracted actions, complex issues, multiple parties, or unusual proof problems;

9 g) Establishing a reasonable limit on the time allowed for presenting evidence; and

10 h) Such other matters as may facilitate the just, speedy, and inexpensive disposition
11 of the action.

12 2. The Motion Filing deadline in this matter is January 9, 2015, at 5:00 p.m., and the
13 Parties shall file all motions they may have and serve them on the other parties by this date and
14 time.

15 3. The Parties shall file all oppositions to any motions, if any, and serve them on the
16 other parties no later than January 16, 2015 at 5:00 p.m.

17 4. The Parties shall file all replies to motions, if any, and serve them on the other parties
18 no later January 21, 2015 at 5:00 p.m.

19 5. Any persons requiring special accommodations, auxiliary aids or services to attend the
20 Pre-hearing Conference shall contact and submit their request to Travis Carbon, Office of Public
