## **SCHEDULING ORDER**

On December 5, 2014, a Pre-Hearing Conference was heard before Public Auditor Doris Flores Brooks and Hearing Officer Delia Lujan Wolff. Attorney Kevin J. Fowler appeared on behalf of Appellant Morrico Equipment, LLC ("Morrico") and Attorney Vanessa L. Williams appeared on behalf of the Guam Solid Waste Authority ("GSWA"). The Public Auditor **ORDERS:** 

- 1. The deadline for parties to file motions is December 19, 2014.
- 2. Oppositions to all motions shall be filed by December 26, 2014.
- 3. Replies to oppositions shall be filed by January 2, 2015.
- 4. The Public Auditor will determine whether or not oral argument will be scheduled on any motions filed.
- 5. The parties shall file the following materials by January 12, 2015:
  - a. Formal hearing briefs stating the parties' respective positions supported by applicable authorities;
  - b. A statement of stipulated facts;
  - Witness lists;
  - d. Exhibit lists; and
  - Pre-marked hearing exhibits.

- 6. The Hearing on this appeal shall commence at 9:00 a.m., on January 20, 2015, at the Public Auditor's Hearing Room, Room 907, DNA Building, Hagåtña, Guam.
- 7. It is further ordered that GSWA shall serve a copy of this Scheduling Order upon each other person or company who submitted a bid or who is a prospective bidder, in order that any of the other bidders or prospective bidders may seek to participate in this appeal as an interested party.
- 8. It is ordered that GSWA file with the Public Auditor proof of service of the Scheduling Order and that it served in accordance with the immediately preceding paragraph. The responsibility to serve a copy of the Scheduling Order on the other bidders or prospective bidders is imposed upon GSWA because it is the entity that is most likely to have the correct names and addresses for such competing bidders or prospective bidders.
