Dear Ms. Acfalle:

As a result of GSA's response to our clarification questions received on February 23, 2015 (copy attached), PDS is filing this PROTEST in accordance with 5 G.C.A. § 5425(a) in reference to the above GSA RFQ.

PDS makes this timely protest for the following reasons:

1. The 1Gb WAN service being procured under this RFQ is the same as the GGWAN services previously procured under GSA-IFB-064-11 (Bid Form Part 11) that is currently under procurement appeal. Temporary procurement of these services is subject to the terms of the Settlement Agreement entered into by PDS, GSA, the AG, and OPA on May 18, 2012 (copy attached). GSA has violated this agreement for its failure to condition the term of the services according to the Settlement Agreement (see point #4).

GSA is reminded that PDS has filed a timely protest of the above referenced procurement under 5 G.C.A. § 5425(g) and no further action on this procurement can be taken until this protest has been duly reviewed and an appropriate determination made.
