Dear Dr. Okada:

In planning and performing our audit of the financial statements of the Guam Community College (the College) and its discretely presented component unit, collectively a component unit of the Government of Guam, as of and for the year ended September 30, 2009 (on which we have issued our report dated April 30, 2010), in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States, we considered the College's internal control over financial reporting as a basis for designing audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the College's internal control over financial reporting. Accordingly, we do not express an opinion on the effectiveness of the College's internal control over financial reporting.

Our consideration of internal control over financial reporting was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in internal control over financial reporting. However, in connection with our audit, we identified, and included in the attached Appendix I, deficiencies related to the College's internal control over financial reporting and other matters as of September 30, 2009 that we wish to bring to your attention.

We have also issued a separate report to the Board of Trustees of the College, also dated April 30, 2010, on our consideration of the College's internal control over financial reporting and on our tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements and other matters.

The definition of a deficiency is also set forth in the attached Appendix I.



SECTION I – CONTROL DEFICIENCIES

We identified, and have included below, control deficiencies involving the College’s internal control over financial reporting as of September 30, 2009 that we wish to bring to your attention:

Recording of Transactions in Proper Period

Comment: The following invoice was not recorded in the proper period.

Recommendation: We recommend that liabilities be recognized upon receipt of goods or services.

Capital Assets Incorrectly Recorded as Expenditures

Comment: Certain capitalizable assets were incorrectly recorded as expenses. This could result in an overstatement of operating expenses and an understatement of net assets.

Recommendation: We recommend that expense accounts be regularly reviewed for items of a capital nature in accordance with College policy.

Account Reconciliation

Comment: Certain accounts receivable subledgers were not properly reconciled to the general ledger account.

Recommendation: We recommend that reconciliations be performed on a monthly basis and differences be investigated and resolved.

Encumbrances

Comment: An amount of \$33,436 (purchase number 0900134) was expensed during the year but was still encumbered at year end.

Recommendation: We recommend that expended amounts be adjusted from encumbrances in a timely manner.

Disposal Report

Comment:

1. Disposal form number ROS-9002 did not reflect the authorized signature of the Inventory Management Officer and the President.
2. Internal numbering is not utilized to track disposal forms issued.

Recommendation: We recommend that disposal forms be approved by authorized personnel and numeric sequences be utilized to track disposal forms.

SECTION II – OTHER MATTERS

We identified no other matters involving the College's internal control over financial reporting as of September 30, 2009.

SECTION III – DEFINITIONS

The definition of a deficiency that is established in AU 325, *Communicating Internal Control Related Matters Identified in an Audit*, is as follows:

A *deficiency* exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct misstatements on a timely basis. A deficiency in design exists when (a) a control necessary to meet the control objective is missing or (b) an existing control is not properly designed so that, even if the control operates as designed, the control objective would not be met. A deficiency in operation exists when (a) a properly designed control does not operate as designed, or (b) the person performing the control does not possess the necessary authority or competence to perform the control effectively.

MANAGEMENT'S RESPONSIBILITY FOR, AND THE OBJECTIVES AND LIMITATIONS OF, INTERNAL CONTROL OVER FINANCIAL REPORTING

The following comments concerning management's responsibility for internal control over financial reporting and the objectives and inherent limitations of internal control over financial reporting are adapted from auditing standards generally accepted in the United States of America.

Management's Responsibility

The College's management is responsible for the overall accuracy of the financial statements and their conformity with generally accepted accounting principles. In this regard, management is also responsible for establishing and maintaining effective internal control over financial reporting.

Objectives of Internal Control over Financial Reporting

Internal control over financial reporting is a process affected by those charged with governance, management, and other personnel and designed to provide reasonable assurance about the achievement of the entity's objectives with regard to reliability of financial reporting, effectiveness and efficiency of operations, and compliance with applicable laws and regulations. Internal control over the safeguarding of assets against unauthorized acquisition, use, or disposition may include controls related to financial reporting and operations objectives. Generally, controls that are relevant to an audit of financial statements are those that pertain to the entity's objective of reliable financial reporting (i.e., the preparation of reliable financial statements that are fairly presented in conformity with generally accepted accounting principles).

Inherent Limitations of Internal Control over Financial Reporting

Because of the inherent limitations of internal control over financial reporting, including the possibility of collusion or improper management override of controls, material misstatements due to error or fraud may not be prevented or detected on a timely basis. Also, projections of any evaluation of the effectiveness of the internal control over financial reporting to future periods are subject to the risk that the controls may become inadequate because of changes in conditions, or that the degree of compliance with the policies or procedures may deteriorate.
