14 I **EUGENE RIOS** hereby declare and state as follows:

- 15 1. I am the fleet sales manager at Cars Plus, LLC.
- 16 2. I am very familiar with the Dodge Durango Special Service Vehicle.
- 17 3. The Dodge Durango Special Service Vehicle is specifically equipped for law
- 18 enforcement purposes.
- 19 4. The Dodge Durango Special Service Vehicle comes equipped with an integrated rear
- 20 prisoner transport seat.
- 21 5. These seats are specially designed for law enforcement purposes and will prevent a
- 22 detainee from hiding any weapons, contraband in-between seat cushions.
- 23 6. The cover of the seat is made of plastic, but it is fully integrated with the seat and
- 24 does not come with a separate cover.
- 25 7. This plastic cover allows for easy cleaning of the rear prisoner transport seat.

1 8. GPD is familiar with this product, because they are the same seats that come
2 equipped with the Dodge Charger Pursuit.

3 9. I believe that the rear seat that comes equipped in the Dodge Durango Special
4 Service Vehicle is comparable in quality, function and durability with the rear seat
5 that comes equipped in the Ford Interceptor.

6 10. The Dodge Durango Special Service Vehicle comes equipped with paddle-shifters
7 that are mounted on the steering column.

8 11. The center console in the Dodge Durango Special Service Vehicle is built with room
9 for a clean installation of GPD's radio equipment and would meet all of GPD's
10 requirements.

11 12. The Dodge Durango Special Service Vehicle meets all bid specifications and can
12 perform all of the functions needed by GPD.
