IT IS HEREBY STIPULATED AND AGREED by and between the parties, through their undersigned counsel, that the motions briefing schedule and motions hearing currently set for Wednesday, February 3, 2015 at 1:00 p.m. be suspended and that the schedule set for the hearing for the appeal be suspended. The reason for the suspension is due to the key representatives for Triple J Motors ("Triple J") and Cars Plus having reached an acceptable settlement of this matter, which the General Services Agency ("GSA") and the Guam Police Department are currently considering, and the need to finalize this settlement.


It is further stipulated that, in the event finalization of the settlement does not occur: the parties will promptly notify the Hearing Officer; Triple J will have three days from this notification date to file its Opposition to the Motions to Dismiss filed by Cars Plus and GSA; thereafter, Cars Plus and GSA will have seven days to file their Replies; and counsel for the parties will confer and file a proposed scheduling order with dates for the

motions hearing, the filings regarding the hearing for the appeal, and the hearing for the appeal.

Accordingly, for good cause, the Hearing Officer finds that the motions briefing schedule and hearing currently set for Wednesday, February 3, 2015 at 1:00 p.m. and the schedule for the hearing on the appeal be suspended while the parties finalize their settlement of this matter.
