The solicitation that is the subject of this appeal would be funded by the Federal Communication Commission ("FCC") which is overseen by the third-party Universal Service Administrative Company for Education-Rate ("E-Rate") programs. See Declaration of Vincent Dela Cruz Regarding Funding Timelines Par. 4 ("Decl"). The funding is a subsidy that would cover eighty-five percent (85%) of the expense incurred for E-Rate programs including wireless local area network installations. Decl. Par. 5. In order to obtain the subsidy the Guam Department of Education ("GDOE") must complete an application which requires an intent to award and signatures from all parties included for the E-Rate solicitation. Decl. Par. 6. GDOE would not have solicited for this service but for the funding application and the eighty-five (85%) off of expenses incurred for E-Rate services. Decl. Par. 7.

Should this matter not be finally decided by May 26, 2016, or an extension be granted by the funding source, GDOE would not be privy to the funding that was the basis for and that GDOE relied on in order to obtain and fund the E-Rate services. *Decl. Par.* 8. But for the automatic stay pursuant to Title 5 Guam Code Annotated Section 5425(g), GDOE would have canceled this E-Rate service if GDOE did not make the May 26, 2016 deadline. *Decl. Par.* 9 The funding application will not be available again until the next E-Rate cycle 2017. *Decl. Par.* 10.
