Form and Filing:

1. On June 9, 2006, the OHS requested the GSA to award a contract for the Warning Systemt to S.E.S. USA, Inc. ("SES") through a sole source procurement. On June 27, 2006 and June 28, 2006 the GSA issued "Purchase Order Nos. PO66A06288 and PO66A06304" for the Warning System to SES.

On December 5, 2006, within 14 days of learning of the procurement, RadioCom filed its formal protest ("Protest") of the GSA's determination to solicit the Warning System through a sole source procurement. RadioCom is a Guam corporation and is a vendor of a competing warning system. Pursuant to 5 G.C.A. § 5214, an agency may only acquire goods or services through sole source procurement when "the Chief Procurement Officer ... determines in writing that there is only one source for the required supply, service or construction item" As RadioCom offers an early warning system, SES was not the only source for the system. Further, pursuant to 5 G.C.A. § 5008, "[a]ll procurement of supplies and services shall be made from among businesses licensed to do business on Guam and that maintain an office or other facility on Guam" Rather than procure the warning system from RadioCom, a business licensed to conduct business on Guam, the OHS/GSA procured the Warning System from a company doing business in Washington State. RadioCom further incorporates by reference herein all grounds for this appeal as set forth in its January 18, 2007 Comment on Agency Report and the January 18, 2007 Declaration of Victoria G. Borja.

On January 9, 2007 the GSA denied RadioCom's protest and RadioCom has, therefore, exhausted all administrative remedies.

- 2. RadioCom requests that the Office of Public Auditor rule that the reason given by the OHS/GSA for utilizing a sole source procurement for the warning system and for denying RadioCom's Protest constitutes an abuse of discretion and that the matter be remanded to the OHS/GSA with instructions to solicit the Warning System through a sealed bid procedure as authorized by the Guam Procurement Law.
- 3. RadioCom hereby incorporates by reference all documents submitted in its December 19, 2006 Notice of Appeal herein, all documents submitted by the OHS in its December 29, 2006 filing with the OPA and all documents submitted by the GSA in its January 9, 2007 letter denying RadioCom's protest.
