## Agency Report:

On June 23, 2006, the GSA, received a request from the OHS to procure an All 1. Hazards Warning System (Early Warning System), together with a justification for sole source procurement, based on interoperability and standardization the existing equipments currently used by the military and the entire island of Guam.

Review of the sole source justification was substantiated by a an email addressed to Mr. Leo Espia, Planner, OHS, from the Command Naval Region Marianas Emergency Annunciation Tower that the existing or current equipment being utilized by the Navy is designed and built by S.E.S., USA INC. In addition, the S.E.S., USA INC. provided documentation that S.E.S., USA INC., is the only company that can interface with the Warning System installed at the Naval Base and Air Force Base on Guam. The Interim National Preparedness Goal issued March 31, 2005 and the Homeland Security Presidential Directive/HSPD-8 also emphasized the importance of other Federal civilian departments and agencies, to establish and implement streamlined procedures for the ongoing development and adoption of appropriate first responder equipment standards that support nationwide interoperability and other capabilities consistent the national preparedness goal, including the safety and health of first responders.

On June 27, 2006, the GSA based on the factual documentations provided as justifications to support the request for sole source procurement was more than justified.

- GSA hereby requests that the Office of the Public Auditor thoroughly review the justifications provided by OHS justifying the request for sole source procurement that the GSA did its part in diligently ensuring that proper justifications were provided prior to executing purchase order numbers P066A06288 and P066A06304, and sustain the award.
- GSA hereby incorporates by reference all documents submitted in its Agency 3. Report, all documents provided by the OHS and procurement documents issued by the GSA.
