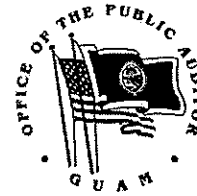

1 **THIS MATTER** came before the Office of the Public Auditor on February 5, 2008 for a
2 Pre-Hearing Conference. The Appellant was present and was represented by his Counsel of
3 Record, Mr. G. Anthony Long, Esq. No representatives for the Purchasing Agency were present,
4 however, the Purchasing Agency was represented by its Counsel of Record, Mr. Aaron R.
5 Jackson, Esq. The following schedule is hereby ordered, but remains subject to change at the

8 **Motion Filing Deadline:** February 12, 2008 at 2:00 P.M.
9 All Pre-Hearing Motions shall be filed no later than this
10 date and time.

11 **Motion Hearing:** February 14, 2008 at 2:00 P.M.

12 **Hearing Date:** February 21, 2008 at 1:00 P.M.
13 (Notice to issue no later than ten days prior – February 11,
14 2008)

15 Parties shall file, no later than February 14, 2008, their
16 respective Witness Lists, Exhibit Lists with four copies of
17 all Exhibits, Admissions of Fact and List of Issues which
18 require evidence or arguments to be presented at the
19 hearing. The Parties may file stipulated joint witness,
20 exhibit, and issues lists, and admissions of fact in lieu of
21 filing such documents separately. The parties shall file
22 Hearing Briefs summarizing their arguments concerning
23 contested issues no later than February 19, 2008. The
24 Parties may, but are not required to, submit additional
25 briefs on the issue of Remedies no later than February 25,
26 2008. The Hearing will proceed in the following order:
27 (1) Opening Statements of the Parties; (2) Appellant's
28 Case in Chief; (3) The Purchasing Agency's Case in
 Chief; (3) Closing Statements of the Parties.
