GMHA CANNOT PROVIDE WRITTEN MINUTES OR RECORDINGS OF MEETINGS HELD BY GMHA CONCERNING THE CANCELATION OF GMHA BID 023-2007 BECAUSE THEY DO NOT EXIST.

PSA moves the Office of the Public Auditor to compel GMHA to produce:

- 1. All written minutes of meetings held by or on behalf of [GMHA] in connection with GMHA Bid 023-2007 which concerns the removal and replacement of the Fire Alarm System Project, which includes but is not limited to the decision to cancel or reject the submitted bids.
- 2. All recordings of meetings held by or on behalf of [GMHA] in connection with GMHA Bid 023-2007 which concerns the removal and replacement of the Fire System Project, involving the decision to cancel or reject the submitted bids.

The documentation requested does not exist. There were no meetings held by or on behalf of GMHA in connection with the cancellation of the Bid. *See Declaration of Danny C. Matanane* (February 14, 2008) at ¶ 3. Thus, GMHA cannot provide the requested documents.

The Facilities Maintenance Departments Evaluation Committee has completed the review process for the above referenced project. Pacific Security Alarm and Kevin and Steve Corp were the two (2) companies that submitted their bid package for the subject project. The department finds that both companies have discrepancies on the required documents of the seal bid. The following cites the findings:

- 1. Pacific Security Alarm
  - a. Failed to acknowledge the bid invitation cover sheet.
  - b. Failed to submit resume of a Master Electrician or Professional Electrical Engineer. Required to be submitted along with the seal bid package.
- 2. Kevin and Steve Corp.
  - a. Fail to submit Descriptive Literature as required on the bid. See General Terms and Conditions Page 3 item 20.
  - b. Fail to submit a C20 license
  - c. Fail to submit a subcontractor listing

The Committee determines that the price being offered by both companies has far exceeded the Government construction cost estimate by over \$300,000.00.

Therefore, we recommend canceling this by bid due to discrepancies noted regarding bid package submittals and insufficient of funds to execute the project. Once funding can be identified, we wish to re-bid the project.
