Pacific Security Alarm,, Inc., ("PSA") submits the below facts which it deems to be uncontroverted in this appeal.

1. Guam Memorial Hospital Authority ("GMHA") issued an invitation to bid for the Removal and Replacement of the Fire Alarm System at Guam Memorial Hospital.
2. The solicitation for the Removal and Replacement of the Fire Alarm System at Guam Memorial Hospital is known as GMHA Bid No. 023-2007.
2. PSA submitted a bid in response to the invitation to bid..
3. The bids were opened on July 13, 2007
4. PSA was the lowest responsive and responsible bidder.
5. By document dated August 7, 2007 GMHA canceled the bid on ground of insufficient funds.
6. PSA received notice of the bid cancellation for insufficient funds on August 9, 2007.

7. PSA filed a protest which was received by GMHA on August 22, 2007.
8. GMHA denied the protest by letter dated November 1, 2007.
