
This is to advise you that the Office of the Public Auditor Hearings Officer has granted an extension in response to PAG’s December 4, 2007 “Request for Extension of Time to File

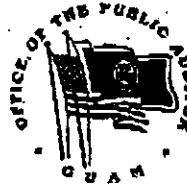
