# ATTACHMENT 1

## STATEMENT ANSWERING ALLEGATION OF APPEAL

The Department of Chamorro Affairs solicits Request for Proposal for RFP No. CV08-007 (Bad Debt Collection Services)

On February 15 & 16, 2008, the Department of Chamorro Affairs, solicited bids for Bad Debt Collection Services for the Chamorro Village operation in Hagatna. No pre-bid conference was held.

The bid opening was held on February 26, 2008. In response to the solicitation, the Department of Chamorro Affairs received four timely bids from United Pacific Collection, Art Design & Services (ADS Debt Recovery), Oceania Collection Services and Guam Marianas Collection Agency. No bid was indicated in bid packaged for Oceania Collection Services and United Pacific Collection, except for Art Design & Service (ADS Debt Recovery) mentioned a 32% of amount per debt collected and Guam Marianas Collection Agency bid package indicated a contingency fee only – to be determined upon negotiation.

Oceania Collection Services, Guam Marianas Collection Agency and United Pacific Collection representative verbally provided a percentage rate during the bid opening. Oceania Collection Agency representative mentioned a 33 1/3% collected with 20% intro rate which was submitted in writing after the bid opening. Guam Marianas Collection Agency representative mentioned a 25% with a 50% offisland contingency fees and United Pacific Collection representative mentioned a 33 1/3% plus interest rate.

Concluding the bid opening the department mentioned that it will need to review the bids further to decide on the possibility of a multiple of sole bid award to be announced on a later date.

On April 15, 2008, the department selected the lowest bidder excluding all additional information provided after the bid opening. Notification letters were sent via fax on April 17, 2008 to all bidders.

On April 21, 2008, the department sent a response letter to Oceania Collection Services inquiry on the selection of the lowest bidder.

On April 22, 2008, Oceania Collection Services sent a formal letter appealing the department's decision based on the lowest bid selected.

On April 28, 2008, a meeting was held with Oceania Collection Services representative to discuss the selection based on information provided on the bid packaged, excluding all information provided after the bid opening.

Based on the bid information provided the department stands behind its decision in the selection of Guam Marianas Collection Agency as the lowest bid and request that the appeal of Oceania Collection Services be dismissed.
