7. Under 2-GAR Div. 4 § 12104(c)(4), Xerox may file Comments on the agency report within ten days after the OPA receives the agency report.


8. Xerox respectfully asks that it be allowed an opportunity to file its Comments no later than August 22, 2008, ten days after its counsel first became aware of the appeal.


