When filing all other required documents with our office, please provide one original and two copies to OPA, and serve a copy to Fukuda Enterprises. Although the Guam Procurement Law and Regulations require only one copy of the procurement record, OPA respectfully asks that DOE provide one original and two copies of the said record, which will be distributed as follows: Copy-1: Master File; Copy-2: Public Auditor; and Copy-3: Hearing Officer.
