Dear Mayor Salas:

In planning and performing our audit of the financial statement of the Mayors' Council of Guam for the year ended September 30, 2016 (on which we have issued our report dated April 24, 2017), in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States, we considered the Mayors' Council of Guam's internal control over financial reporting as a basis for designing audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Mayors' Council of Guam's internal control over financial reporting. Accordingly, we do not express an opinion on the effectiveness of the Mayors' Council of Guam's internal control over financial reporting.

Our consideration of internal control over financial reporting was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in internal control over financial reporting that might be significant deficiencies or material weaknesses and therefore, material weaknesses or significant deficiencies may exist that were not identified. However, in connection with our audit, we identified, and included in the attached Appendix I, a deficiency related to the Mayors' Council of Guam's Asan-Maina Mayor's Office internal control over financial reporting as of September 30, 2016 that we wish to bring to your attention.

The definition of a deficiency is also set forth in the attached Appendix I.



## SECTION I – DEFICIENCIES

We identified, and have included below, deficiencies involving the Mayors' Council of Guam's Asan-Maina Mayor's Office internal control over financial reporting as of September 30, 2016 that we wish to bring to your attention:

### 1. Receipts

Five receipt transactions totaling \$300 from a fundraising event were received in May 2016 but were deposited in September 2016.

We recommend that receipts be timely deposited.

Auditee Response: On May 16, 2016 a fundraising event was held for our village candidate for the Guam Liberation. As we had sponsored her, a check was written out to Jamaican Grill for that purpose and monies collected by the candidate for the lunch plates will in turn be deposited to the Asan-Maina Mayor's Office Municipal Planning Council non-appropriated funds account. However, our candidate dropped out, had relocated to an unknown address and had to be "tracked" down, which took several months to locate her and collect the monies for this fundraiser. As she only provided three (3) checks written out to the Asan-Maina Mayor's Office and one (1) check written to "cash", as the sponsor of the candidate, I had to absorb the remainder of the costs, in which I wrote a personal check for. This is the only reason for this untimely deposit of these monies.

## SECTION II – DEFINITIONS

The definition of a deficiency is as follows:

A *deficiency* in internal control over financial reporting exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct misstatements on a timely basis. A deficiency in design exists when (a) a control necessary to meet the control objective is missing or (b) an existing control is not properly designed so that, even if the control operates as designed, the control objective would not be met. A deficiency in operation exists when (a) a properly designed control does not operate as designed, or (b) the person performing the control does not possess the necessary authority or competence to perform the control effectively.

## **MANAGEMENT'S RESPONSIBILITY FOR, AND THE OBJECTIVES AND LIMITATIONS OF, INTERNAL CONTROL OVER FINANCIAL REPORTING**

The following comments concerning management's responsibility for internal control over financial reporting and the objectives and inherent limitations of internal control over financial reporting are adapted from auditing standards generally accepted in the United States of America.

### **Management's Responsibility**

Management is responsible for the overall accuracy of the financial statements and their conformity with accounting principles used to prepare the financial statements. In this regard, management is also responsible for establishing and maintaining effective internal control over financial reporting.

### **Objectives of Internal Control over Financial Reporting**

Internal control over financial reporting is a process affected by those charged with governance, management, and other personnel and designed to provide reasonable assurance about the achievement of the entity's objectives with regard to reliability of financial reporting, effectiveness and efficiency of operations, and compliance with applicable laws and regulations. Internal control over the safeguarding of assets against unauthorized acquisition, use, or disposition may include controls related to financial reporting and operations objectives. Generally, controls that are relevant to an audit of financial statements are those that pertain to the entity's objective of reliable financial reporting (i.e., the preparation of reliable financial statements that are fairly presented in conformity with accounting principles used to prepare the financial statements).

### **Inherent Limitations of Internal Control over Financial Reporting**

Because of the inherent limitations of internal control over financial reporting, including the possibility of collusion or improper management override of controls, material misstatements due to error or fraud may not be prevented or detected on a timely basis. Also, projections of any evaluation of the effectiveness of the internal control over financial reporting to future periods are subject to the risk that the controls may become inadequate because of changes in conditions, or that the degree of compliance with the policies or procedures may deteriorate.
