- If it appears obligation of the funds will not occur by the September 30th deadline. 7. GDOE may re-program the funds for use in other grant-approved activities. However, reprogramming may not occur without OSEP approval, and must occur prior to the deadline for obligation. I have been informed by the Federal Programs Division of GDOE that obtaining approval to re-program the funds may take several weeks. An internal deadline of June 30, 2014 has therefore been set for the application for re-programming of the FY 2012 OSEP funds.
