THIS MATTER, came before the Hearing Officer for a Scheduling Conference on September 19, 2018. The Purchasing Agency was represented by its Counsels of Record, Assistant Attorney Generals SHANNON TAITANO, ESQ., and JOSEPH PEREZ, ESQ. The Appellant was represented by its Counsel of Record, DAVID A. MAIR, ESQ. After hearing the arguments of the parties and for good cause shown, the Hearing Officer hereby **ORDERS** the following:

1. The Appellant's Request to Consolidate its Appeals in OPA-PA-18-003 and OPA-

1 PA-18-005 is hereby GRANTED. There was no opposition from the other parties and the
2 Hearing Officer finds that the Parties, the Procurement Record, and the witnesses in both cases
3 are identical and that consolidation of OPA-PA-18-003 and OPA-PA-18-005 is in the interests of
4 Judicial Economy and the furtherance of achieving an expeditious resolution of these matters.

5 2. The Parties shall adhere to the following revised expedited briefing schedule:

6 a. Supplemental Procurement Record. The Purchasing Agency shall not be
7 required to file a second procurement record, but shall supplement the procurement record it has
8 filed in OPA-PA-18-003 to include any and all correspondence and additional documents
9 concerning the Appellant's May 30, 2018 Supplement to Protest and the Purchasing Agency's
10 July 26, 2018 response to said supplement to protest. The Purchasing Agency shall file said
11 Supplemental Procurement Record no later than 5:00 p.m., October 5, 2018.

12 b. Supplemental Agency Report. The Purchasing Agency shall file a
13 Supplemental Agency Report concerning the Appellant's allegations in OPA-PA-18-005 and
14 serve it on the other parties no later than 5:00 p.m. on October 12, 2018.

15 c. Comments to the Supplemental Agency Report. The Appellant may file
16 its Comments to the Supplemental Agency Report and serve said comments to the other parties
17 no later than 5:00 p.m., on October 22, 2018.

18 d. Rebuttal to Comments on the Supplemental Agency Report. The Purchasing
19 Agency shall file its Rebuttal to Comments on the Supplemental Agency Report, if any, and
20 serve said rebuttal on the other parties no later than 5:00 p.m., on October 29, 2018.
