#### 2. TECHNICAL APPROACH

To ensure that all requirements are met and completed in a timely manner as well as to build and create successful working partnerships with its customers throughout the term of this contract, LMS developed a technical approach. This approach demonstrates the Company's understanding of the Scope of Work (SOW), its objectives and the ability to accomplish it.

Every aspect of the technical approach focuses on providing GVB with the most efficient and effective opportunity to save time and money while receiving high quality service and performance. The Company's strategy is to use a lean approach as well as the utilization of innovative tools and equipment, which are proven successful on multiple grounds maintenance and landscaping projects held by the Company.

#### 2.1. General

LMS ensures to equip all necessary labor, tools, equipment, and appurtenances to administer thorough maintenance of landscape areas within Tumon, Guam, inclusive of San Vitores Road from Bishop Flores Rotunda to Hotel Nikko, JFK road (Route 14A), Australian Cable Road (Santos Hill), Bishop Flores Rotunda grounds, GVB office grounds and the first median at Governor Joseph Flores Park entrance.

LMS will provide daily and periodic maintenance amidst public rights of way to incorporate, but not limited to:

- The maintenance of grass areas, inclusive of road shoulders and medians;
- The maintenance, improvement and the recurrent inspections of landscaping and the irrigation system;
- Provisions of all necessary labor, equipment, acts and items needed to properly carry out the requirements needed to complete the project;
- Replacements and repairs to landscape areas that are deemed minor. Should any major items need attention, this is to be brought to the attention of the Contracting Officer or an authorized representative.

#### 2.2. Work Requirements

#### 2.2.1. Checklists


As an attachment to this Specification, LMS will thoroughly review and complete all pertinent items on The Weekly Checklist. Prior to the end of the month, LMS will further review and complete The Monthly Checklist for the ongoing month. Lastly, LMS will submit all necessary checklists to GVB or an authorized representative for their final review and approval.

#### 2.2.2. Care of Planted Areas

#### 2.2.2.1. Trees

With respect to Tree Trimming and Pruning, safety and knowledge is crucial to ensure that quality work is performed safely and effectively. LMS employs several tree trimmers who all have been personally trained by Master Arborists and completed the 24-Hour Fall Protection Competent Person Training Program. Mr. Roland Quitugua will serve as LMS' ISA Certified Arborist to oversee the performance required for this project.

LMS ensures the maintenance and inspection of trees in order to keep them healthy, free of disorder and infestation of pests. LMS will extract non-structural branches below 7', crossing branches, and suckers from lower tree trunks that could affect the public's safety. Daily minor pruning of trees is to only extract dead, broken, dangerous, or crossing branches with the supervision of a certified or equivalent Arborist. Tree pruning will be done at a maximum of two (2)-times per year for non-palm trees and three (3)-times per year for palm trees. The appropriate integrated Pest Management (IPM) will be utilized to treat trees with signs of stress, pest, and disease immediately, that is most suitable to the plant.





LMS will provide Guam Environmental Protection Agency (GEPA) certified pesticide applicators to apply chemicals before 7:00 A.M., providing pedestrian blockade and appropriate signage for pedestrians to take caution. In conformity to Guam Code Annotated (GCA 16-62), LMS will obtain a permit prior to conducting any tree pruning. All care, maintenance, pruning, fertilization, etc. of trees is in conformity with American National Standard Institute (ANSI) A300 (Parts 1, 2, and 3) and ANSIZ133.1-200 Standard Practices and Safety Requirements - accessible at GVB and Department of Agriculture.

#### 2.2.2.2. Shrubs

LMS ensures to prune and maintain the health of a shrub to form a dense, continuous hedge, branching fully to the ground, and remove those that extend beyond the curbs or sidewalks; taking note that prior to cutting or pruning another shrub, sterilization is necessary. LMS understands that when the Scaveola (Nanaso) shrubs reaches the height of five feet (5'), pruning is necessary for the shrub to stay within a minimum height of three feet (3') to zero inches (0"). If a shrub is found dead, LMS will replace the shrub with an identical species with the approval of the Contracting Officer. All care, maintenance, pruning, fertilization, etc. of trees will be in conformity with American National Standard Institute (ANSI) A300 (Parts 1, 2, and 3) and ANSIZ133.1-200 Standard Practices and Safety Requirements.

#### 2.2.2.3. Fertilizer

LMS ensures to provide an experienced horticulturalist, who will prepare soil test and recommendation prior to the application of all fertilizer formulations, such as foliar, granular, or organic. The application of fertilizer will be based on the recommendation, providing soils with the appropriate nutrient and soil chemistry as they become apparent.

#### 2.2.2.4. Weeding

LMS will kill and remove weeds that are larger than two inches (2") high or wide from planters. To kill the weeds, LMS will utilize herbicides that are compatible and acceptable. LMS will remove emerging weeds that grow into paver block areas, planted areas, sidewalks, curbs, gutters or pavements and neatly trim the edges of paver block walks and adjacent areas. With the approval of GVB, LMS is able to provide the option of preand post-emergent herbicide usage.

#### 2.2.2.5. Mulch and/or Rock Layer

LMS ensures that additional mulch will be added to shrub planters and decompose mulch as needed. Should organic mulch be used, a layer of no less than two inches (2") and no more than four inches (4") in depth. Rocks will be uniform in color, appearance, and in size.


#### 2.2.2.6. Grass Areas

LMS will mow or trim grass to the height of one-inch (1") when the height reaches three inches (3") with the omission of centipede grass, which will be cut no less than two-inches (2"); on a twice a month basis. LMS will remove and dispose of site grass clippings, replace dead or severely yellow grass with a similar or a better species of grass with the approval of the Contractor's Officer, at the expense of the Company. LMS will also ensure that bush cutters must be kept away from trees and shrubs; understanding that girdling is not acceptable.

#### 2.2.3. Irrigation

#### 2.2.3.1. Water Application and Scheduling

LMS ensures to conserve and utilize water in an efficient manner, that all watering rules and regulations are followed accordingly, and utilize hand water as needed in order to supplement natural rainfall to keep plants





in a happy and healthy stress-free environment. LMS understands that irrigation must be made by the use of a permanent irrigation system and that any failure of it shall not relieve the Company of its responsibility. LMS will maintain and upkeep the condition of the irrigation system as well as be responsible for its maintenance and complete operation with the exceptions noted in the specifications provided by GVB.

#### 2.2.3.2. Irrigation System Scheduled Maintenance

LMS ensures that the irrigation systems are well maintained and inspected on a weekly basis. Should any damages arise, the Company will make sure that these are reported to an authorized representative. In the occurrence of run-off water, LMS ensures that spillage will not occur onto restricted areas and shall immediately shut down should this occur.

#### 2.2.3.3. Irrigation System Repair

Should any damages occur, with the exception of excluded damages, LMS is held responsible for such damages and shall report them immediately to an authorized representative. LMS ensures that weekly checks are completed in a timely manner as well as carefully observe any signs of plant wilting, which may indicate a malfunctioned irrigation system.

#### 2.2.4. Trash and Recycling Collection

LMS ensures that all trash and recyclables are properly separated, removed and disposed from all designated areas as indicated in the specifications in a timely and efficient manner. On a monthly basis, LMS will provide GVB with a data report of collected recyclable materials – data will include, but not limited to volume/weight, recipients of recyclables, dates, etc.

#### 2.2.5. Cleanup and Litter Removal

With respect to sweeping and blowing, LMS recommends that the Contractor minimize the impact on foot traffic and utilize street sweepers to move quickly and efficiently clean up debris and waste after cutting. Utilizing a mechanical street sweeper will minimize potential damage to oncoming vehicles and lessen the amount of time that the crew will be exposed to the hazards of traffic. LMS is equipped with an Osprey Street Sweeper in its fleet of equipment. This efficient Osprey is a versatile option in the NiteHawk family. It provides the capability to sweep and clean the Tumon area in approximately three (3) hours.

#### 2.2.6. Chemicals and Pesticides

Due to the sensitive nature of pesticide and herbicide chemicals and the heavy traffic associated with Tumon, CORE Certified Applicators will apply all pesticide and herbicide to ensure that the work is conducted in a safe and effective manner. LMS has a total of twenty-six (26) CORE Certified Applicators and will have one (1) CORE Certified Applicator specifically dedicated to this project. The Company's CORE Certified Applicators passed the "Guam Environmental Protective Agency CORE Training" with twenty-six (26) qualified employees and the "Certification for Applicator of Restricted Pesticides" Training with four (4) qualified employees.

#### 2.2.7. Disposal

LMS will provide a certified and valid Solid Waste Permit as issued by the Guam Environment Protection Agency (GEPA) prior to the disposal of any solid wastes. Such waste shall be disposed at an approved GEPA disposal area.



#### 2.2.8. Project Schedule

If awarded the project, LMS shall commence the project on October 1, 2018 and cease on September 30, 2019. LMS understands that the project may be extended and awarded for an additional two years. LMS reassures that the Landscape Maintenance Schedule as stipulated in the requirements will be followed accordingly.

#### 2.3. Postponed Work Schedule Make-Up

LMS will commence work from the date of Notice to Proceed and continue thereafter in accordance with the service schedule as set forth thereafter. If inclement weather or any other unavoidable condition prevents LMS to perform scheduled work, we shall notify the Contracting Officer and obtain approval for a scheduled makeup work. LMS will propose another date to perform the corresponding number of workday(s).

#### 2.4. MISCELLANEOUS PROVISIONS

LMS will provide a minimum of four (4) employees and a certified ISA Certified Arborist, who will be on-site during any tree trimming activity on the medians and shoulders. LMS ensures that the Quality Control Project Manager will supervise safety and conduct post project site inspections with GVB, periodically.

#### 2.4.1. Communications and Reports

LMS ensures that there will be constant communication with GVB, providing the name and contact number of LMS' representative. With the maturity of the landscape, LMS understands that certain maintenance procedures will be eliminated or added. LMS will submit signed and dated checklists, as well as results or reports of testing within two (2) weeks of receipt of such results. Two (2) weeks prior to the awarding of contract, LMS will submit a detailed maintenance schedule that will outline the tasks and manpower at the site to GVB.

#### 2.4.2. Illegal Dumping

Upon discovery, LMS will not eliminate any illegal dumping sites—GVB will be notified immediately to document and report accordingly to the proper authorities.

#### 2.4.3. Public Release of Information


LMS ensures that information or photographs will not be released to the public that concerns any relation to the service or materials of this contract, without GVB's written approval. LMS will also insert the substance of this paragraph into each subcontract and the purchase orders

#### 3. COMMITMENT TO SAFETY

Safety is more than a manual—it is how LMS operates. Although the achievement of an exceptional safety record is a valuable goal, the Company heavily stresses the benefits of an outstanding Safety Program and continuously strives for improvement. No task is so important or urgent that the Company cannot take the time to perform tasks in a safe manner.

The Company's commitment to safety is driven by Upper Management, who ensure that safety policies and procedures are properly managed and implemented by LMS personnel and its subcontractors. The Company takes pride in its ability to create a safe working environment for its employees, subcontractors, and clients. The Company's approach to safety is guided by an established Safety and Health Policy, based on compliance with regulatory requirements and conformance with industry standards and best practices. It is the Company's belief that safety should be managed by the following principles:

- Health and safety are among the most important considerations in any undertaking
- All injuries, illnesses, accidents, and incidents are preventable





- Working safely is a condition of employment
- No employee is required to work at-risk or around unsafe conditions
- Protection of property, equipment, supplies, and materials are to always be used at the site of work

Orderly and expeditions work performance is key to avoid interruptions and delays that can be caused by lack of attention to safety controls.

#### 3.1. Work Safety Plan


With the TLM project, certified competent safety officers will be onsite at all times. Tumon is a high visibility area with significant foot traffic. We have approximately thirty-three (33) Competent Safety Officers that have passed the 40-Hour Contract Safety Training for Contractors (EM385-1-1). In addition, we have twenty-three (23) Quality Control inspectors that have passed US Army Corps of Engineer 40-Hour Construction Quality Management for Contractors.

In support of the Company's principles, every reasonable effort is made to promote a safe environment through planning, sound design, safe work practices, personnel training, and compliance with applicable regulations and industry standards. LMS has an SSHO with approximately fifteen (15) years of experience in safety. LMS ensures that the Company stays in compliance with all safety and accident prevention requirements.

The key elements of the Company's Safety and Health Policy are:

- 1. Working Environment: Employees are provided a safe working environment. Every effort is made in the elimination or control of accidents, fire, health and occupational hazards associated with the Company's activities and to maintain the health of employees by preventing injury and exposure to illness. To accomplish this, the Company provides its employees with all reasonable safeguards, safe working equipment, necessary personal protection, and first-aid and medical services.
- 2. Management: Management is responsible for implementing this safety policy throughout all levels and areas of the Company's operations and is responsible to provide a safe working environment.
- 3. Supervisory: Supervisory personnel at all levels are held accountable for the safety of the Company's employees working under their supervision and are expected to conduct operations in a safe manner at all times. Supervisors conduct daily toolbox briefs and record such briefs on a daily production report submitted to management.
- 4. **Employees:** Employees are expected to follow safe procedures and take an active part in the tasks of protecting themselves, their fellow co-workers and their respective work activities. Available safety equipment must always be properly used and maintained. Rules of conduct and rules of safety shall be observed. Violations may be cause for discharge.
- **5. Safety Performance:** Safety Performance is an important part of the evaluation of a supervisor's overall performance and is a major consideration in the promotion and advancement of personnel within the Company. Real-time communication shall be conducted in terms of daily safety performance and shall be supported with pictures and documentation, which are provided to the Company's SSHO daily.
- **6. Education and Training:** The training of workers in the Safety Program and in the administration of safety activities is a requirement for all supervisors. They are required to provide leadership and direction in this area. Each crew will have at least one certified competent Safety Officer present at all times and audits to be conducted by our SSHO.
- 7. Safety Awards and Incentives: Certain safety awards and incentives are given from time to time on a discretionary basis as determined by the Company to assist employees in the awareness of the Company's Safety Program. employees are rewarded at all levels for stellar safety performance with zero incidents through recognition and prizes.

The Company takes all injuries and/or incidents very seriously. All injuries and/or incidents, no matter how slight or small, must be reported to an LMS Supervisor. In the event an injury or incident occurs on this project,





LMS will notify the Manager on Duty and ensure that all required notification documents are completed and submitted in a timely manner. The Company's Site & Safety Health Officer (SSHO) will investigate all incidents and ensure that reporting is completed on a timely basis. LMS will also make any recommended changes or improvements to prevent repetition of accidents.

#### 3.2. Safety Awards

LMS is a proud and long-time recipient of the merit-based National Safety Training Evaluation Process (STEP) award. LMS gradually increased its safety standards and has been recognized by the Associated Builders and Contractors, Inc. (ABC) in the form of numerous awards. Specifically, LMS received awards in the following categories: Platinum in 2016, Diamond in 2017, and Platinum in 2017. The STEP program provides an organized approach to analyzing and further developing a company's Safety and Loss Prevention Program. The Company's commitment to safety was recognized in 2015, when LMS was named the winner of the National Safety Excellence Awards recognizes companies who exhibit a continued commitment to jobsite safety and whose safety performance and programs are judged to be exemplary by the ABC National Environment, Health & Safety (EH&S) Committee.

The National Safety Awards Program honors the highest level of achievement in safety performance in ABCs STEP program. These awards are presented to companies that possess exceptional safety records and recognize safety as a core value as evidenced by leadership commitment, safety culture, and rigorous employee training program. LMS was placed in an elite class of only 20 National Safety Excellence Award winners in the country. 





#### A Statement Answering the Allegation of the Appeal

The Guam Visitors Bureau responds to disappointed bidder JJ Global's allegations on appeal.

#### Relevant Procedural History

The Guam Visitors Bureau delivered a notice of non-responsibility to JJ Global on 01 November 2018, not 7 November 2018 as JJ Global claims. See Procurement Record at pp. 175-76. As part of its Appeal, JJ Global submitted a document which purports to establish that it was served the notice of non-responsibility on 07 November 2018. See Appeal at attachment B. This is significant since Appellant had no more than 14 days to protest after it learned of the reasons for its aggrievement. See 5 Guam Code Ann. 5425(a), "[t]he protest shall be submitted in writing within fourteen (14) days after such aggrieved person knows or should know of the facts giving rise thereto." If Appellant received the notice on the 1<sup>st</sup> of November, the protest to the agency was untimely and the Office of Public Accountability (OPA) is without jurisdiction over this appeal. However, if the notice was delivered on the 7<sup>th</sup> the protest was timely.

JJ Global was served on the 1<sup>st</sup> and not the 7<sup>th</sup>. See affidavits, Garrett and Linek, attached. In this case Appellant has delivered a false document in evidence to the OPA with the intent to deceive and defraud the agency. JJ Global has thus committed a crime. See 9 Guam Code Ann. §§46.25, 52.55, 55.10. This information will be the subject of a motion to dismiss an appeal and a motion to allow discovery.

#### The GPA Contract

The Guam Visitors Bureau received reliable information that JJ Global did not perform a contract with GPA to the satisfaction of that Agency. The Bureau invited the Appellant to provide information to dispute this finding. See Appeal at attachment D. Appellant declined to do so.

#### **GWA Contract**

The Guam Visitors Bureau received reliable information that JJ Global did not perform a contract with GWA to the satisfaction of that Agency. The Bureau invited the Appellant to provide information to dispute this finding. *See Appeal at attachment D*. Appellant declined to do so.

#### **DPR Contract**

The Guam Visitors Bureau received reliable information that JJ Global did not perform a contract with DPR to the satisfaction of that Agency. The Bureau invited the Appellant to provide information to dispute this finding. *See Appeal at attachment D.* Appellant declined to do so.

#### **GIAA Contract**

The Guam Visitors Bureau received reliable information that JJ Global did not perform a contract with GIAA to the satisfaction of that Agency. The Bureau invited the Appellant to provide information to dispute this finding. *See Appeal at attachment D.* Appellant declined to do so.

#### A Stay

There is no stay in effect. The contract was awarded prior to receipt of a protest.

#### JJ Global's Request for Relief

The Guam Visitors Bureau asks that the Appellant take nothing by its appeal and that relief be denied.

The Guam Visitors Bureau asks that it be awarded costs and attorneys fees for defending against this action.

The Guam Visitors Bureau asks that it be allowed to conduct discovery in regard to a false document submitted by Appellant.

The Guam Visitors Bureau asks that this matter be submitted to the Guam Police Department and the Office of the Attorney General for investigation and possible prosecution.
